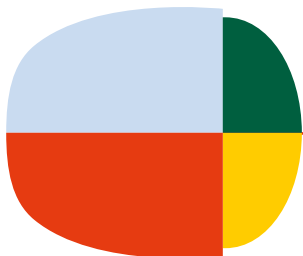

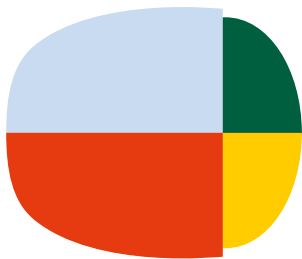

Information notice pursuant to art. 13 ff regulation (EU) 2016/679 on the processing of personal data (hereinafter, “gdpr”)

We hereby inform you that, pursuant to EU Regulation 2016/679 (hereinafter, the “Regulation”), your personal data will be processed by the **Accademia Nazionale di Santa Cecilia**, located at Auditorium Parco della Musica, Largo Luciano Berio, 3 – 00196 Rome, Italy. The Academy can be contacted by email at **presidenza@santacecilia.it**, by telephone at **+39 06 80242 503–504**, and by fax at **+39 06 80242 311**, in its capacity as Data Controller (hereinafter, the “Academy” or the “Controller”). The **Data Protection Officer (DPO)** may be contacted via email at **dpo@santacecilia.it** or by regular mail at the address of the Academy indicated above.

The Academy will collect your personal data through the completion of the form above, which requires you to provide, in particular, your personal and contact details, your tax identification number, and the amount you choose to donate to the Academy. Based on the amount donated, you may acquire one of the types of membership indicated therein. In the event that the donor is a person other than the member, or in the case of a donation in memory of someone, the Academy will also collect the personal and contact details of the member, which you warrant – accepting full responsibility – that you are authorized to transmit based on the member’s consent or another appropriate legal basis for the lawful processing of such information. To this end, you provide full indemnity for any claims, demands, or damages arising from the processing of such personal data in violation of applicable data protection laws, which may be brought against the Controller by third parties.

The purposes for processing the aforementioned personal data are as follows:

- a) **To manage the donation** you have offered, pursuant to Art. 6(1)(b) of the GDPR;
- b) **To publish your name** on the Academy’s institutional website and in other communication materials (e.g., general concert calendars, program booklets, etc.). The legal basis for this processing is your **consent**, pursuant to Art. 6(1)(a) of the GDPR;
- c) **To send promotional communications, newsletters**, and invitations to events (e.g., press conferences, exhibitions, etc.) related to the Academy, via email and telephone. The legal basis for this processing is your **consent**, pursuant to Art. 6(1)(a) of the GDPR;
- d) **To comply with legal obligations** to which the Controller is subject, including the transmission of your tax code to the **Ministry of Culture (MIBACT)** to enable you to benefit from the tax treatment associated with donations to the Academy (“Art Bonus” under Art. 1 of Decree-Law No. 83/2014, converted with amendments by Law No. 106/2014). This processing is carried out pursuant to Art. 6(1)(c) of the GDPR;
- e) **To meet potential legal defense requirements**, pursuant to Art. 6(1)(f) of the GDPR.

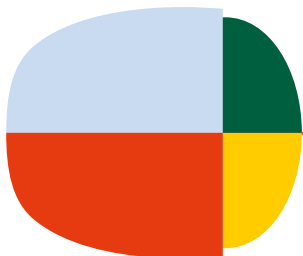
Please note that any consent you may provide for the above processing activities may be **withdrawn at any time**, without affecting the lawfulness of processing based on consent before its withdrawal. Providing your personal data is optional, but failure to do so may prevent the Academy from accepting your donation.

All personal data processing operations will be carried out in strict compliance with confidentiality and security principles required by law, and in accordance with the principles of fairness, lawfulness, transparency, and relevance adopted by the Academy.

Your personal data will not be disclosed to third parties, except to professional firms and companies providing auditing and financial certification services, as well as to parties for whom disclosure is required by law or regulation. Your data will be retained only for the time strictly necessary to manage your donation, as outlined above. However, if you provide your consent, your name will be published online on the Academy’s institutional website.

We also inform you that the Controller **does not intend to transfer your personal data outside the European Union**. In any case, should such a transfer become necessary, it will be carried out in accordance with one of the legal methods permitted under current





legislation, such as the data subject's consent, the adoption of Standard Contractual Clauses approved by the European Commission, the selection of entities adhering to international data transfer programs (e.g., the EU-US Privacy Shield), or the use of countries recognized as adequate by the European Commission. In the event of such a transfer, you will be provided with a specific notice.

You have the right to request from the Controller, at any time, access to, rectification, or erasure of your personal data, or to object to its processing; to request the restriction of processing in the cases provided for in Article 18 of the GDPR; to withdraw your consent at any time pursuant to Article 7 of the GDPR; to obtain your personal data in a structured, commonly used, and machine-readable format in the cases provided for in Article 20 of the Regulation; and to lodge a complaint with the competent Supervisory Authority (Italian Data Protection Authority) pursuant to Article 77 of the GDPR, if you believe that the processing of your personal data violates applicable laws.

You may submit a request to object to the processing of your personal data pursuant to Article 21 of the GDPR, indicating the reasons justifying your objection. The Controller reserves the right to assess the request, which may not be accepted in the presence of compelling legitimate grounds for the processing that override your interests, rights, and freedoms. Requests must be submitted in writing to the Controller or the DPO at the contact details provided above.
